





The Watering Hole has hosted trivia nights the past several months covering 80s Rock, Yacht Rock and Disco so I thought I would share some election trivia. In June 1978 the first homeowners were elected to the Board to begin transitioning from the developer Presley Homes. In the 46 years since, 71 different homeowners have served. At 16 years, Jan Curtis has the most years served. Over the past eight elections 2016-2023 an average of 547 ballots out of a possible 1,405 have been submitted. The high was 644 in 2016 and the low 435 in 2017. On average, 39% of the membership submits ballots. We would like to see that % increase this year so please vote!!

A high point of member participation occurred December 1988 when 1,038 ballots were counted with 876 approving purchase of the Clubhouse and Recreation Center.

A number of our past Board Members still live in Nellie Gail Ranch and we acknowledge each of your efforts at making Nellie Gail Ranch the community it is today! Please support your 2024 candidates by submitting your ballot.

Orange County Fire Authority Large Animal Rescue

Orange County Fire Authority (OCFA) serves the Nellie Gail Ranch community in more ways than fire protection and emergency medical services. They also serve our community by providing large animal rescue services. On March 11th one of our resident horses became trapped in a concrete drainage channel between a property line fence and wood bridge. The Large Animal Rescue unit was dispatched and they set up a pully system to safely remove the horse and return it to its stall for after rescue care. Working with large animals that are scared and hurt can be dangerous work and we were all grateful to the OCFA team for the tender care provided to safely extricate the horse.

Rescues of this sort are not just spontaneously implemented without a plan. OCFA trains and prepares Large Animal Rescue teams that specialize in these unique rescue events. Members of the Nellie Gail Ranch Equestrian and Trails Committee were invited to witness a training session that occurred March 25th at Shea Therapeutic Riding Center in San Juan Capistrano. Sixty plus crew from all of Orange County and Corona attended training on use of a sling for rescues and proper horse handling to load horses on trailers in event of fire.

We wish to publicly acknowledge here our appreciation for the dedicated and professional service provided by OCFA to the Nellie Gail Ranch community, both human and equine.



EMERGENCY PREPAREDNESS

ASSEMBLING YOUR DISASTER/EARTHQUAKE KIT

As devastating earthquakes and volcanoes continue to occur in "our ring of fire," we should use this opportunity as a reminder to be fully prepared for any disaster, whether man-made or natural. The information in this article may be the most important information you read for the rest of the year. That is because your completed earthquake/disaster kit will be the key to you and your family's survival. In the past several months, in addition to the pandemic, there have been several measurable earthquakes in our southern California region and in the US, we have seen tornados and tropical storms, floods and breeched dams, wildfires, and even dust storms from the Saharan Desert. Additionally, there have been several large earthquakes on the "Pacific Rim of Fire," the zone where earthquakes and volcanic eruptions are common (and the zone in which we live.) Recall from our previous articles that teams of scientists and other experts feel that a 7.8 magnitude earthquake (approximately 8 times stronger than the Haiti earthquake) striking Southern California within our lifetime is inevitable. When such an event occurs, we will likely be without gas, water and electricity; and public assistance will be slow or non-existent. The disaster/earthquake kit is the cornerstone to

being prepared and self-sufficient. Put another way, your disaster kit is the key to your survival. Implement your kit now and you won't have to think about it for the rest of this year.

Your disaster/earthquake kit should be able to sustain you and your family for a minimum of 14 days, although nearly all experts and relief organizations advise preparing for 30 days. The author of this article, having worked in national disasters and having seen firsthand the response time of aid, utilities, public service, etc., strongly advises that you prepare for a minimum of 30 days. This article will provide you with the basics of assembling such a kit. It is not meant to be exhaustive but more a point of reference from which you can tailor to your specific needs. Additional references are also provided at the end of this article.

One question that is frequently asked is, "Why do I need an disaster/earthquake kit? I already have everything I need in my home." This may be true but very short-sighted. Imagine everything that is on a shelf or cabinet, and the contents of every drawer are strewn on your floor. Then add 3-6 inches of water from the broken water main that you were able to turn off but only after the water flooded your bottom floor. Lastly, add some broken glass and some drywall from your collapsed ceiling. This is not the



time to being collecting your supplies for survival. Another frequent question is, "If it's that bad, why don't I just leave?" This, too, is short-sighted: you are assuming that no bridge or underpass is affected between your home and your destination, you are assuming that you have enough fuel to get to your destination (remember that with no electricity, there will be no working fuel pumps and even if you can get fuel, you're not going to be using your credit card,) and you are assuming that you have enough food and water in your car for any travel and unexpected stops. Lastly, if only 10% of the residents Orange County felt similarly and decided to leave, our roads would be in gridlock for days and it is likely that you will go nowhere fast. Your best option may be to "shelter in place" and you will need a disaster/ earthquake kit to do so successfully.

On the following page is a Disaster/Earthquake Supplies list that you can use to help establish your family's Earthquake kit. Please tear this out or copy it to make as your own list. Additionally, we have provided you some important information below that further explains of some of the items on the list.

WATER. You should store at least one gallon of water per person per day, more if elderly, ill, breastfeeding, or in warm environments. Water should be stored in original containers in a cool dark place away from paints or other petroleum-based products. Be sure to observe the "use by" or expiration dates on the label. Additionally, water can be stored in food grade, water-rated drums or containers. If storing water in this manner, you should add the appropriate water preservative and seal the drum. This water should then be replaced every 1-2 years. Water from your home's hot water heater can also be used for drinking as long as the appropriate steps are taken to preserve the purity of this water during a disaster. Information on how to utilize your water heater's water, as well as water purification instructions (using water purification tablets or unscented bleach) can be found on the Nellie Gail website, www. nelliegailranch.org and clicking "resources."

FOOD. Store at least a 2 week supply (and preferably a 1 month supply) of non-perishable foods. Ideally, select foods that require no refrigeration, preparation or cooking and require little or no water. Also, select foods that you normally use at home so you can rotate this in and keep the stored foods fresh.

SHELTER. If you are unable to inhabit your home, you will need a place to shelter. A RV, such as a motorhome or trailer will make an excellent place to shelter. For others, a tent or tarp will protect you from any rain or wind, and provide you with shade when needed. Extra clothing can be items that you normally would have given to charity.

MEDICATIONS AND FIRST AID. Prescription medications should be in their original container and enough for one month. You should also have a written list of the medication, including dosage, instructions and the Rx number to aid in refills. Health insurance usually won't allow you to purchase an extra month's worth of medication, but your physician can provide you with an extra prescription that you can purchase without going through insurance, or you can ask your physician if he or she has samples of your medication. Be sure to rotate your medications to avoid storing expired medications.

PETS. Pets often play an important role in our lives so be sure to plan for their emergencies as well. You should also be prepared to evacuate with your pet,

however, keep in mind that most public shelters will not allow you to bring your pet. As such make appropriate contingency plans, possibly setting up a "buddy system" of pet care with neighbors who also have pets.

MISCELLANEOUS. Cash is important because credit card terminals and ATM machines will be nonfunctional when the electricity is out. Copies of your important documents will make it easier for you to file insurance claims, access bank accounts, etc. New flashlights that utilize LED light bulbs are far superior as they use less electricity prolonging battery life, are less prone to burning out light bulbs, and are generally brighter. If you are going to purchase a flashlight, consider purchasing the LED flashlights.

STORAGE AND LOCATION OF YOUR EARTHQUAKE

KIT. The idea of an earthquake/disaster kit is to have all necessities in one location that is stored away from sources of heat and light. Good areas include the back corner of one's garage or in an infrequently used closet. The location should be on the bottom floor of multistory buildings and next to an exterior wall for easy access should there be a building collapse. Lastly, the items should be stored in a sturdy container. The metal "contractor's box" found at construction job sites is an excellent type of container for your earthquake kit.

Again, this article and the accompanying supply list will help you get started on your earthquake kit. It is recommended that you copy this list and use it as the foundation of your family's earthquake kit. Future articles will include work and car preparation, and water purification. THE INSTINCT TO HONOR

The instinct to honor those who have sacrificed for our freedoms is especially evident in England and Scotland, from where my wife Karen and I have recently returned. British memorials from Bath to Inverness mark the British and allies' military sacrifices in world wars and more localized conflicts like Afghanistan and the war on terror. It is the same instinct that caused the City of Laguna Hills to select the 3/5, 1st Marines Division, for special recognition 15 years ago after that unit lost 25 Marines fighting in Sangin, Afghanistan in 2010 and that motivates the City to pay tribute to the 3/5 Marines killed in action every Memorial Day.

One cannot travel far in the British Isles and not see memorials like below honoring those who died in the line of duty fighting the enemy. These memorials are permanent reminders of how, as one plaque below a memorial in Inverness, Scotland reads, "When you go home, tell them of us and say, 'For your tomorrows, these gave their todays.'" The British memorials include tributes to the flyers who defended Britain from German bombers in the last months of 1940 during the Battle of Britain; their average age ... 22. Perhaps Churchill's most famous speech memorializing the RAF pilots who fought off the destruction of Britain and saved it from Nazi invasion includes the immortal line, repeated on a memorial to these flyers, "Never in the field of human conflict was so much owed by so many to so few."

The City's Memorial Day celebration includes several parts, including a static display with 3/5 Marines escorting the public around its different components,

as well as banners commemorating the 25 3/5 Marines who lost their lives in the Sangin fight in late 2010. Marines also run in the Memorial Day races sponsored by the City in silent tribute to their fallen comrades. By placing the 3/5 Marines at the head of its Memorial Day commemoration each year, Laguna Hills pays homage to those Marines who gave up their todays for our tomorrows.

Special Ballot Measure

Should Nellie Gail Ranch continue to contract for Mobile Patrol services?

Option 1: YES Please **continue** 24-hour mobile patrol services at a cost of \$17.26 per home per month (\$207.16 annually).

Option 2: NO Please discontinue mobile patrol services.

The total "Yes" votes will be compared to the total "No" votes. The higher count will **prevail.**

Special Ballot Measure Statement Should Nellie Gail Ranch continue to contract for Mobile Patrol services?

After evaluating homeowner requests to implement patrol services in the Nellie Gail Ranch community, the Board of Directors approved a contract for mobile patrol services in March 2017. After competitively re-bidding, Superior Protection Services was selected as the service provider effective August 1, 2023. The current scope of work includes providing dedicated 24-hour, 7 days per week, mobile patrol services for the Nellie Gail Ranch Owners Association streets and recreational facilities including Clubhouse, Swim, Tennis, Parks and Equestrian facilities to provide an observational presence and to act as a deterrent to criminal activity. The current cost for this service is \$16.70 per home per month (\$200.43 annually). The Special Ballot Measure for retaining the service represents a projected increase of 3.4%.

Since implementing this service homeowners have provided input both in favor of and opposed to the ongoing budgeting for this service. Crime statistics vary based on a number of factors including the Sherriff's apprehension of active criminals in our area. This makes it difficult to know specifically if the mobile patrol is playing a role as a deterrent for criminals since there is no way to calculate statistics for crimes not committed.

This matter is submitted on the ballot to provide the Nellie Gail Ranch Membership the opportunity to again decide whether or not to continue to budget and contract for this service.

If the "Yes" votes exceed the total of "No" votes then services will be renewed under contract. A "Yes" vote does not obligate the Association to remain with the current service provider as that decision can be altered at any time subject to evaluation of the vendors post orders and performance.

Historical Votes:

The past five years the ballot included a measure for a membership vote to continue or discontinue 24-hour mobile patrol services.

Special Ballot Measure

24-hour mobile patrol services (\$17.26 per home per month - \$207.16 annually)

The focus of 24-hour mobile patrol is to deter criminal behavior by being a visible presence throughout the community and reporting substantive incidents. Each shift the officer is responsible for maintaining awareness of suspicious activities, circumnavigating all community streets twice and conducting a foot patrol of all parks and the recreation center. There are three shifts in each 24-hour period.


The following is a summary of incidents the current patrol company Superior Protection Services submitted reports on for the period August 1, 2023, through March 30, 2024.

- · Homeowner Reports of Suspicious Activity (loitering, persons, sales teams, vehicles) 37
- · Patrol Officer Reports of Suspicious Vehicle / Activity 36
- · Patrol Officer Reports of Suspicious Person / Activity 33
- Facility Check (i.e. broken sprinkler, recreation center gate unlocked, open equestrian center stall, alarm) - 20
- · Vandalism 7
- · Safety Hazards (fallen trees primarily) 6
- · Noise Complaints 2
- \cdot Patrol Officer Assaulted with Deadly Weapon 1
- \cdot Other (i.e. nuisance animal, reports of accidents, or police activity) 15

The above resulted in 23 calls by the mobile patrol officer to the Sheriff with one call regarding a suspicious man with bolt cutters and an E-bike that was stolen on Moulton, leading to an arrest and bike owners retrieving their property.

Please discontinue mobile patrol services option

If the total "No" votes exceed the "Yes" votes, then mobile patrol services will be discontinued. The current contract expires July 31, 2024, which means the service may be discontinued at that time if the vote is opposed to continuing the service. Discontinuing the service will not result in a direct reduction in assessments for this fiscal year that ends September 30, 2024. The 2024-25 budget will be evaluated in July and August evaluating all anticipated expenses and services under contract and the budget will either include or not include the mobile patrol services based on the membership vote.



Nellie Gail Garden Group

The Nellie Gail garden group were so busy the last two months planting succulents and growing seedlings to sell at the Easter Egg Hunt. By the time you read this it has come and gone. So I hope everyone had a wonderful time.

At the same time of trying to grow succulents for our sale; I was praying and hoping for a normal year of temperatures and rain. I actually could not remember a normal winter.

When our dormant trees didn't try to blossom too early from a few days of intense heat. And then the cold kills them. Instead we got wonderful cold temperatures and lots of rain.

It has been difficult deciding when to fertilize for Spring. I waited till the first week of March using organic products that are slower in absorption compared to synthetic products. I wanted a slow start to spring so the blossoms would not bloom all at once. Just as a precaution if a cold wave of temperatures or wind happens we can still produce some fruit. So far things are going well.

California weather has been all over the map the last few decades. The rest of the world is also suffering greatly. I am not here to tell you what to believe but to offer solutions. I am always reading articles to find these solutions for our up and down climate. And I became interested in doing many of these practices to see how I can help my garden.

I like this term "Grow a climate change resilient garden".

So when I first moved here one of my best friends is a geologist and he looked at my property and said you have a terrible vertex of run off water here prime for mudslides. And sure enough we had three mudslides. I said to him ok we will do whatever it takes to fix this problem. So the first thing we did was elongate the pool to protect the house



from mudslides. The next was to add in more drains and to make sure all the old ones were working properly. We also added trenching to the yard so the water run off went into the main drain. All this worked well; the mud went into the pool.

This is not as bad as one would think. First thing you do is drain the pool with sump pumps and clean up the mud with a pressure washer. And after it's really clean fill it back up again and shock it with chlorine to make sure all the bacteria is killed.

But three years of mud is a lot to deal with. I went asking neighbors to please grow on your hillsides. And they added in acacia bushes. The difficult part I did not know is that we are responsible for our hillsides. This property is ours not HOA. So runoff mud and water is our problem and our neighbors as well. So what to do next?

I found a succulent, an ice plant type that loves to grow on slopes, extreme drought tolerant, has flowers for bumble bees (first time seeing them in twenty years) and is fire retardant. And then I see them all over the highways as they do a real good job holding up slopes. On cliffs not such a great job because they can become too heavy with water and fall taking the cliff with them. But on slopes they are great!

So we planted this all over along with some rosemary for the bees as well. And now adding in lavender. The bees are so happy I have so many types of native bees in my backyard now. And I have not had mud in my pool in over six years. Even after these terrible rain storms no water has come down either. The trenches are dry, the waterfalls didn't happen. The massive mud stayed on the slopes.

The iceplants hold the mudflow and they absorb the water. So instead of a dirt hillside I not only stopped the mudslides I have enriched my garden. And now when I walk up the hillside I am relieved to see how everything is working together. And my cost is next to nothing because these iceplants do not need a lot of water. This is climate fixing.

While I was looking at all the bees I also noticed all the lizards and what they were eating; insects. They were jumping in the air catching termites. In the Spring we will see termites flying out of their wooden homes and out in the yard. Dead wood, old stumps, fences and even railroad ties termites will live in. So if you use a lot of pesticides you would be killing off these lizards that are so beneficial. Everything has a purpose in the garden.

We had an unexpected beneficial friend come into my patio as well. A six foot gopher snake. Since we know what these look like and they are harmless. I was very happy to see this guy!!!! Gopher snakes are longer than rattlesnakes, have a small head and no rattle--but their colors on their skin can be similar. They are not aggressive. Please do not hurt them, we need them to kill our gophers and rats. It's best to walk away when you encounter a snake.

Pictures of some of our pollinators--Rosemary the best because it blooms the most. Aeonium succulant blooms when it's a few years old. A Spice Zee Necta plum is fruit I highly recommend owning. Wisteria super pollinator too!! And yes our snake was back in the yard!
