RESTAURANT RENTAL POLICY

In order to ensure the safety and success of your event, we would like to stress the importance of the following policy. Please read it carefully as you will be held responsible for implementation of all items. Failure to follow these policies may result in additional fees.

1. The reservation and use of the facilities is restricted to Nellie Gail Ranch Owners Association homeowners, Swim and Tennis Center members, and Equestrian Center members (hereinafter known as “Club Members”).
2. Reservations are a minimum of five (5) hours (inclusive of setup and cleanup) and subject to negotiating food and beverage service with The Watering Hole concessionaire. **No outside food or alcohol is permitted.** Certain outside food items may be negotiated with the concessionaire.
3. The facility may be reserved no more than six (6) months in advance and no less than one (1) week notice.
4. The responsible Club Member(s) must be present at all times.
5. Seating occupancy for service to be determined by concessionaire. Max occupancy is 86.
6. Smoking anywhere on the premises is prohibited.
7. The reservation of The Watering Hole facility does not include use of the tennis courts, pool, spa, or the water play area by attendees of the event. The Watering Hole use of the patio area is subject to negotiations with The Watering Hole concessionaire.
8. The Club Member(s) is/are responsible for assuring their guests abide by all rules.
9. The facility may not be used for games of chance or gambling requiring the exchange of money.
10. Open flames are not permitted at any time.
11. Decorations may not be adhered to the walls with tape (other than painter’s tape) or anything that punctures the drywall, framing, cabinets, furniture, or beams.
12. Tables and chairs cannot block exit doors.
13. The responsible Club Member(s) shall arrange for all equipment deliveries and pickups on the day of the event within the rental time. If additional time is needed, such as next day pick up of rental equipment, prior arrangements must be made with the concessionaire two weeks prior to the event.
14. The premises, including restrooms and outdoor area (if used), must be left in the same condition as before the event.

15. Music is permitted during the event; however, it must be contained inside the room and must end or be turned off by 10pm.
 16. The Watering Hole and NGROA are not responsible for items left, lost or stolen before, during or after the event.
 17. Room setups are as is. Any custom setup shall be negotiated through concessionaire.
