TERMS AND CONDITIONS

- Entry is available to all ages; however, minors under 13 years of age must be accompanied by an adult.
- **Pets MUST be on a non-retractable leash (no longer than 6 ft.) or in a carrier.** Pets must NOT be aggressive to people or other animals. Owners are responsible for their pet's behavior. Dogs/cats must be fully vaccinated, registered, and socialized.
- Pet owners must carry their own "poo bags" and collect pet's deposits; owners are responsible for any mess or damage made by their pets on the day of the event.
- At the discretion of the Organizer, owners and their pets may be asked, for any reason, to leave the venue and/or contest.
- Winners will be announced with prizes awarded on the day of the contest. The Organizer does not take any responsibility for late, lost, or misdirected entries. A judge's decision will be final. In the event of a dispute arising out of any aspect of the contest, the decision of the Organizer will be final.
- Prizes are non-redeemable for cash and must be taken as offered. No responsibility will be taken for a winner's loss of prize. All entry forms remain the property of the Organizer.

Release from Liability & Indemnity Agreement

IT IS HEREBY AGREED TO AS FOLLOWS:

1. That I, the undersigned, do for myself and/or on the behalf of my child, spouse, or legal ward, hereby voluntarily participate in the Nellie Gail Ranch Pets on Parade Contest & Expo.
2. That we participate in this event totally at our own risk for injuries or property damage we may incur in relation to this event.
3. That we will be responsible for any and all costs incurred by us for injuries or property damage we may incur in any event and that we are covered by accident-medical coverage now in force.
4. That I do carry personal liability now in force. Further, I am responsible for the negligent acts of myself, my family members and/or legal wards, and my pets.
5. That I am responsible for my own financial loss in relation to theft or damage to my personal property while on the grounds of the event.
6. **RELEASE WAIVER:** That I hereby, for myself, my heirs, administrators and assigns, and family members, release and discharge the Nellie Gail Ranch Owners Association, the owner of the premises on which this event is being held, and all directors, staff, and volunteers of the Pets on Parade event and their respective servant agents and all other participants of and from all claims, demands, action, and causes of action for all injuries sustained to my person, of that of my child, spouse or legal charge, and/or property. INDEMNITY AGREEMENT

As a parent/participant, I know that events with pets/animals are potentially hazardous activities. I assume the risk of myself and/or my child and all other risks associated with the Nellie Gail Ranch Pets on Parade Contest & Expo (hereinafter "Pets on Parade"), including, but not limited to falls, kicks, bites, contact with the participants and/or animals, the effects of weather, the condition of the park, injuries from loading, unloading and handling pets, and all such risk being known and appreciated by me. Knowing these facts, and in consideration of your accepting my entry, I hereby for myself and/or my child covenant not to sue, and waive, release and discharge the Nellie Gail Ranch Owners Association, its board, officers, and event chairman, and any and all sponsors, agents, employees, assigns, or anyone acting for or on their behalf, from any and all claims of liability for death, personal injury, property damage of any kind or nature whatsoever, arising out of, or in the course of mine and/or my child participating in Pets on Parade. The event staff reserves the right of all durations and that all decisions made by the staff are final. Event management reserves the right to restrict entrants to acceptable behavior and attire during the event that it considers objectionable and detrimental to the image of the event.
