

POOL RULES AND REGULATIONS

The rules governing the Nellie Gail Ranch Swim Center are to ensure the safety and comfort of our members and their guests while using the facility. Please read and abide by the following:

- 1. All Nellie Gail Ranch residents and Swim Club members must present their Nellie Gail Ranch photo identification upon entering the Swim Center.
- 2. Residents are limited to three (3) guests at a time unless a reservation has been made in advance by resident. Guests must be accompanied by an adult Nellie Gail resident and will be charged a \$3.00 per person fee upon entering the swim area. Groups of 10 or more people must make a reservation at least 2 hours in advance.
- 3. No one under 13 years of age to be admitted to the pool area unless accompanied by an adult.
- 4. No children under 13 years of age are permitted in the spa without adult supervision.
- 5. Wading pool is intended for children under 6 years of age. Adult supervision is required at all times.
- 6. Parents/guardians are responsible for their children/guests, regardless if a life guard is on duty.
- 7. All members, residents and guests should conduct themselves in an appropriate manner at all times.
- 8. Showering is required before entering the pool.
- 9. Absolutely *NO* running or any type of rough activity (i.e. dunking, pushing, splashing, flipping, or throwing of objects) will be permitted. *NO* playing or hanging on the lane lines.
- 10. No diving permitted. Starting blocks are to be used only under supervision of authorized aquatic staff.
- 11. Stay in designated open swim areas, unless lap swimming.
- 12. Return all patio furniture back to its original location.
- 13. No food allowed in pool. Please use designated tables located around the pool deck and upper patio. Dispose of any food and drinks in designated trash receptacles when finished.
- 14. Absolutely no glass containers permitted in the pool area at any time.
- 15. No gum or sticky candy is allowed in the pool area.
- 16. Notify the Nellie Gail Ranch staff of any spills, maintenance issues, or safety hazards.
- 17. Permission must be obtained from a Nellie Gail Ranch staff member before using NGR owned kickboards or equipment. Equipment must be returned to the appropriate storage bin when finished.
- 18. No toys or floatations allowed. Only floatation devices used to assist in swimming safety are permitted.
- 19. Only designated life guards are permitted on life guard chairs.
- 20. Do not obstruct pump room door, eyewash station, gates or emergency exits.
- 21. No smoking, alcohol or illegal drugs allowed in or near the Swim Center.
- 22. Swim lessons are not permitted without obtaining written authorization from Nellie Gail Ranch staff.
- 23. Proper swim wear must be worn in the pool (i.e. no cut off pants or tennis shorts).
- 24. All children under the age of four (4) (toilet trained or not) must wear swim diaper and tight fitting plastic pants covering the diaper. No diaper changing in pool area. Please use provided space in the restrooms.
- 25. Shirts and shoes must be worn in the Clubhouse. *NO* wet swim wear is allowed in the Clubhouse.
- 26. In accordance with Health Department regulations, no pets are allowed in pool area.
- 27. Lifeguards have full authority to prohibit anyone who does not abide by these rules from using the facilities.
